

Healdsburg is a well know wine destination, and attracts visitors from around the world to its many excellent restaurants, wineries, and shops. The winery is located in a prime industrial area in north Healdsburg. The industrial zoning would allow for further improvements on the parcel with minimum setbacks and height restrictions.

#### HEALDSBURG

Healdsburg is centrally located in some of the best wine growing areas of California. The small Sonoma County town is located about 60 miles north of San Francisco, and only 15 miles from Santa Rosa. The town lies at the intersection between the Dry Creek Valley AVA, the Russian River Valley AVA, and the Alexander Valley AVA. These three AVA's are among the top wine regions in California, and are home to world class wines.

Healdsburg also offers excellent dining, shopping and lodging, all in a picturesque town with historic charm. The area boasts beautiful landscapes and great weather year-round. The town has been picked as one of the best small towns in America by Smithsonian, Fodor's, Men's Journal, and Fox News.

### Winery Property Features

The winery is on a 1.23 $\pm$  acre parcel located at 1480 Grove Street. The parcel has one entrance on Grove Street, and two entrances on Grove Court. All the entrances are capable of receiving large trucks. The parcel is within Healdsburg City Limits, which currently places no case limit on the winery. The building that houses the winery is 2400 $\pm$  sq. ft., all steel construction, on a slab. There is a large overhang that shelters the crush pad.
